- 7. It is therefore prayed that an award of Rs. Lakh may kindly be awarded in favour of the applicants/defendants and against the respondents jointly and severally alongwith Funeral/Burrial, treatment expenses, costs, Penalty 50% of award amount and interest @ 12% per annum from the date of accident/death till the realization of the amount.
